It is hereby confirmed that the quoted lights will provide more lumens and lux on the ground than 400 and 1000 Watt HID lights respectively. The standard HI-Bay without lenses mounted at 5 meter height will yield light levels of more than 300 Lux on the ground.

For mounting highs above 6 meters we recommend the lensed option. In this case mounting at height of 8 meters will yield lighting level of 300 Lux on the ground. By mounting the lensed option at 5 meters lighting levels of more than 400 Lux can be obtained but the amount of horizontal illumination is reduced.

The specifications of the new lights are attached. The standard guarantee is 3 years but 5 years can also be provided.
